

CTN is currently helping more than 5,800 individuals of all ages and all abilities to connect with their community. We can target our impact for seniors, people with disabilities, low income families, children, youth and the organizations that serve them. The widespread impact includes healthier and more independent individuals, less costly care required, families remain employed, stress relieved for all, improved program participation, reach greater self-sufficiency, and robust economy. Fewer transportation barriers exist to access medical care, work, programs, and community life.

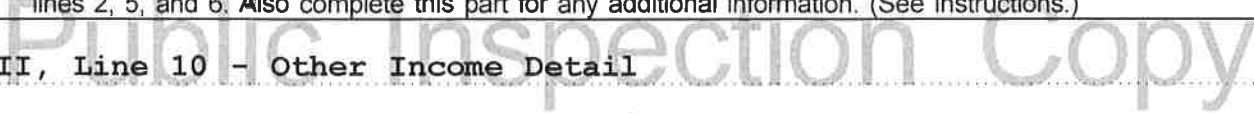
