Major developments:

For CTN, this year was a rebuilding year and a year to prepare for major transitions.

- Succession planning took on a new sense of urgency as the Operations Manager was retiring. This planning was coupled with the reorganization of the operations staffing to become more efficient. A new position of Assistant Director was created to lead operations and develop skills to lead the agency in the absence of the Executive Director.
- This year we had to reduce the medical transportation service by 23% to reduce personnel expenses. People with frequent standing orders became the priority and none of them lost their service. With more support income, we can restore some of this service over the next two years.
- We continued to struggle to hire qualified drivers. The influence of a board member helped the recruitment publicity. We also had to raise wages to be more competitive for the CDL drivers.
- This was our second year for receiving capital support for the building. After 18 months, a one million dollar purchase was reduced to a \$280,000 mortgage balance.
- This was the first full year in our new building which reduced occupancy expenses as part of the financial recovery.
- We ended the fiscal year with a sizable profit. This corrects a two-year cycle of deficits. We also had funding to carry over into the new fiscal year.

Activities Report – The Investment at Work


17,312 trips supported the access of **696** seniors and people with disabilities to medical care and related services. 517 new people registered for this service.

- 36% were minorities, 67% were aged 60 and over, 18% were aged 80 and over
- Over 90% of survey responses feel CTN is responsive to needs, will continue to use, and would refer others.
- 62% of survey responses changed their appointment time so CTN could provide the trip.
- 57% responded that service is vital to remain in current residence.
- Chief complaint is availability in schedule to perform their trip request.

26,705 trips provided children, youth, low income families, seniors, and people with disabilities access to other community resources in partnership with other organizations.




Financial Scoreboard -
