

# Public and Specialized Transportation Services

Steuben County Council on Aging (STAR Transportation) directly operates public transportation, services for individuals with disabilities, and senior citizen programs and services. Transportation is provided anywhere in Steuben County. There are no eligibility requirements to use STAR Transportation. Hours of operation are 7:00 AM to 5:00 PM, Monday through Friday.

# **Public Input Summary**

A transportation needs assessment survey was advertised to the public online and in hard copy format. It was promoted in local print media, social media, flyers, at public meetings, on websites,

and through communications from steering committee members with their peers, employees, and clients. The survey was open from May 19, 2023, through July 24, 2023. Public workshops in June 2023 and virtual meetings in July 2023 provided additional opportunities to discuss transportation with riders and potential riders. Across the region, 4,223 people participated in the public survey.

A total of 299 people from Steuben County participated. Almost forty-six percent of respondents who answered the survey from Steuben County were between 25 to 34, making it the largest group contributing to that county's results.

During the public and virtual workshops, participants were asked to answer the question: What is currently working? Some of the positive areas that participants indicated are working well include the following:

- Rural county transportation
  - Public transportation is available in the county via STAR
  - Door to door service

### **Issues or Challenges**


Workshop participants also shared the most common challenges for the existing transportation network. Common challenges mentioned during the meeting were as follows:

- Service availability
  - Service runs Monday-Friday, 6:00 a.m.-5:00 p.m.
  - No evening or weekend hours
- Lack of awareness of available service options
- Fares too high
- Lack of transportation across county or state lines

Thirty-percent of survey respondents indicated that there wasn't community/public transportation available for them. Twenty-five percent of respondents indicated that an obstacle to using public transportation is that it is unavailable to cross county or state lines. Thirty-two percent of survey respondents stated that lack of accessibility for wheelchair or other mobility device was an obstacle to using public transportation. Thirty-percent of respondents indicated that lack of transportation affects their ability to shop for food, while twenty-five percent indicated they skip or don't schedule medical appointments due to lack of transportation. Over thirty-percent of respondents indicated that cheaper transportation services would improve their ability to get to places they need to go.

### Summary


The main issues present in Steuben County seem to be service limitations and cost of fares. It also appears that the public is unaware of what services exist in their community.




# Demographics

### Population

Steuben County is the fourth smallest county in the region with 34,435 people in the 2020 decennial census. Allen County has the largest population in the region while Wells County has the lowest. Figure 2 below shows the population for each county included in this assessment. Population density in Steuben County varied, with the block groups in Angola with the highest population density. The areas with the next highest density fall around Hamilton, Glen Eden, the western part of Fremont and the eastern part of Angola. The rest of the county has mid to low population densities. Individual county population density maps are included in Appendix C for reference.





### Age

In rural communities, it is common for age to be used as an indicator of current and future transportation demand. That is because as a person ages, they are more likely to need and want alternatives to driving themselves. Older adults are also sometimes living on a retirement or social security income which makes public transportation a more affordable option than owning and operating a personal vehicle.

Steuben County has the second highest percentage of the population age 65 or older, at 20.5 percent, behind Wabash, at 23.1 percent. LaGrange has the youngest population, at 14 percent older adults, with the remaining counties having percentages between 15 to 19 percent older adults. Figure 3 illustrates the county-by-county percentages.



### Zero-Vehicle Households and Households Below Poverty


Households without access to a vehicle are highly likely to need transportation from a public or nonprofit agency. In Steuben County, 5.1 percent of households have no vehicle, similar to Dekalb and Kosciusko counties. LaGrange County has the highest proportion of households without a vehicle, at 27.3 percent, followed by Adams County, at 14 percent. Regionally, 6.8 percent of households have no vehicles. A breakdown by county is provided in Figure 4.

Steuben County has 9.3 percent of its population with income below the poverty level, which is below the regional rate of 10.4 percent. Allen, Adams, Huntington, and Wabash counties have between 11 and 12 percent of residents with income below the poverty level; all the remaining counties have rates under 10 percent. Figure 5 shows the percentages of household incomes below the poverty level for the 11-county region.





### Individuals with Disabilities

In Steuben County, an estimated 14 percent of the population has a disability. All counties have rates between 10.9 and 15.2 percent of the population with a disability, with a regional rate of 12.8 percent, as depicted in Figure 6 below.

Steuben County could participate in a program that assists working individuals with purchasing necessary parts to repair vehicles since close to a quarter of survey respondents stated having a more reliable vehicle would help improve ability to get to places. The program would involve mechanics who volunteer time and/or offer reduce-priced maintenance. Individuals would submit an application and the lead agency would first explore that individuals' options for using public transit. Should the applicant have transportation needs beyond the service provided by any of the local public transit services, the application would then be taken into consideration and evaluated.

- Identify a lead agency to administer the program and develop a board or committee for program establishment and fundraising.
- Identify program parameters and policies.
- Promote the program to potential funders.
- Implement the program through partner non-profit agencies that will identify good candidates for the program.
- Establish and measure program performance.
